


## Privacy, Data Protection and Cybersecurity

We offer a full range of services on privacy, data protection, and cybersecurity, including assistance in seeking adequacy to Brazil's GDPR-like data protection law (the Brazilian Data Protection Act), other sector-specific privacy and data protection laws, in Brazil and abroad (one-stop-shop service).



## Our services cover

- Legal assistance on the compliance with national and foreign laws relating to privacy and data protection, including the Brazilian Data Protection Law (LGPD)
- · Compliance projects to meet the requirements of the LGPD
- Advice on sectorial laws on privacy, data protection and information security laws applicable to a wide range of economic sectors, including health, insurance and financial areas
- Advice on the use of personal data in the context of data analytics, big data, IoT, and other data driven services
- Draft and review of corporate policies and contracts on the use of confidential information and personal data, policies on monitoring of employees, use of social media and IT resources


